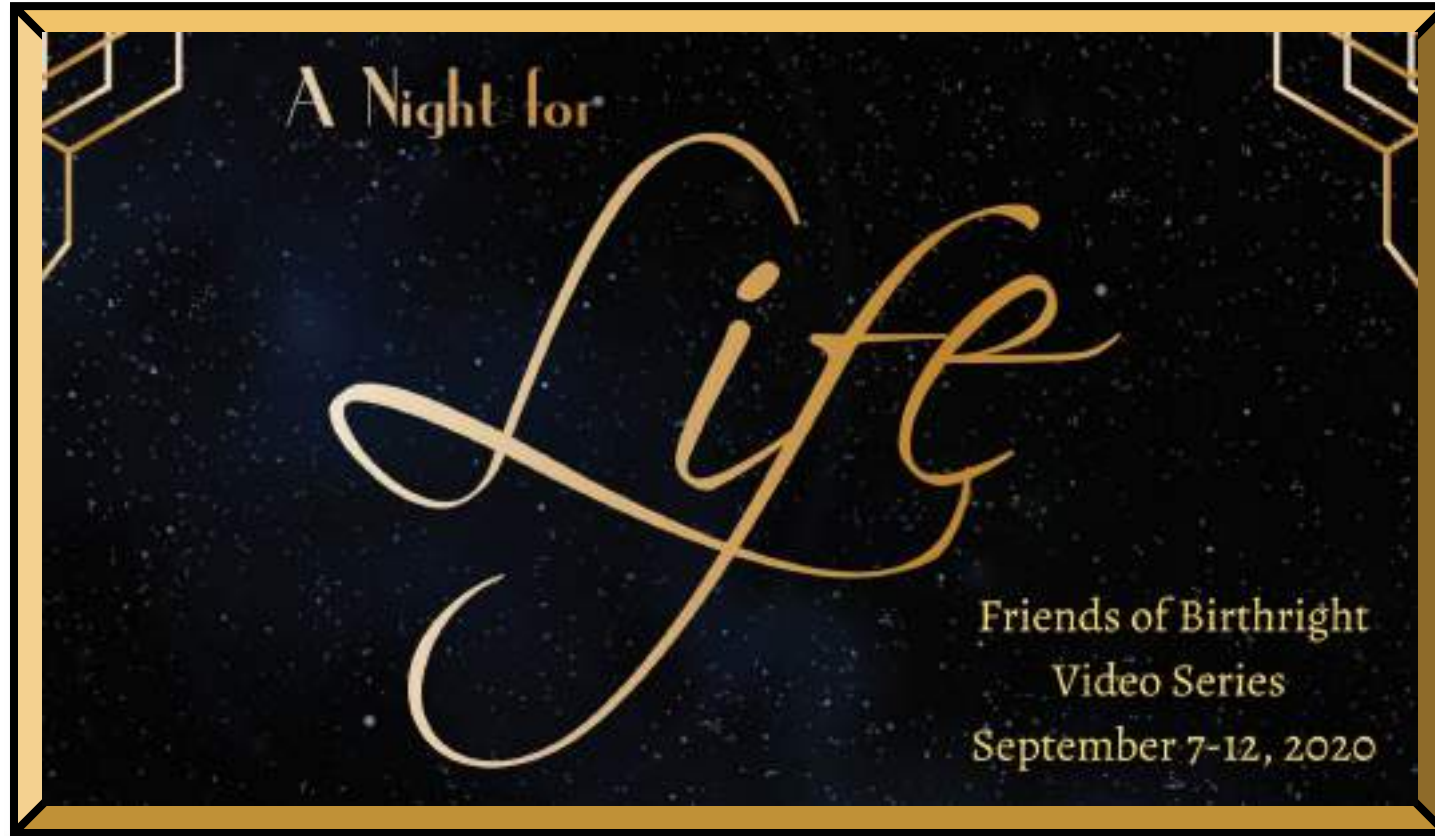

## Missouri Pregnancy Resource Tax Credits

Donations to Birthright Counseling, St. Louis may be eligible for the 50% Missouri Pregnancy Resource Center Tax Credit. The amount of the tax credits available is limited and is determined by the state of Missouri. The benefit of the Missouri Pregnancy Resource Center Tax Credit is that it allows you to deduct 50% of your contribution to Birthright from what you owe the Missouri Department of Revenue in Missouri taxes.
